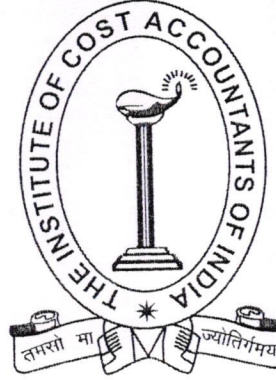

THIS MEMORANDUM OF UNDERSTANDING (hereinafter called the 'MOU') is made on this 15th Day of May, 2019

BETWEEN

THE INSTITUTE OF COST ACCOUNTANTS OF INDIA (ICAI), a statutory body under an Act of Parliament, having its headquarter at CMA Bhawan, 12, Sudder Street, Kolkata – 700 016, West Bengal represented by its President, **CMA AMIT ANAND APTE**, hereinafter referred to as **"ICAI"** (which expression shall, unless excluded by or repugnant to the context be deemed to include its successors in office, representatives, administrators) of the **ONE PART**.

AND

ARKA JAIN UNIVERSITY, JHARKHAND is a private university in Jamshedpur in the state of Jharkhand, India. ARKA JAIN University was established by the Jharkhand State Legislature under THE ARKA JAIN University Bill, 2017' and is the first private university in **JHARKHAND** established by the JGI Group, Bangalore. This university is imparting Undergraduate & Post Graduate Programme, Engineering, Technology and Management Education, Medical & Health Science & Ph.D programme etc. throughout the country.

Objective of the MOU: This MOU intends to create a framework that CMA members with graduation qualification can pursue PhD programme from ARKA JAIN University and the ICAI can be involved in collaborating research study/seminars etc. with the University.

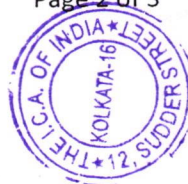
The ICAI and ARKA JAIN UNIVERSITY, JHARKHAND have identified the following areas of mutual co-operation:

- (a) To recognise Members of the ICAI for pursuing PhD programme at ARKA JAIN University.
- (b) To create a framework procedure for the members of the ICAI for pursuing PhD degrees at the University.
- (c) CMA Members with graduation qualification to be considered for pursuing PhD programme in the relevant faculty in the University.
- (d) The Institute may act as the collaborating partner in UGC/ICSSR sponsored seminar of the University. Besides joint seminars, workshops, round table discussion etc. may be conducted at regular intervals.

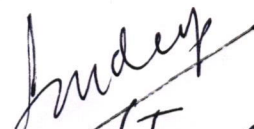
