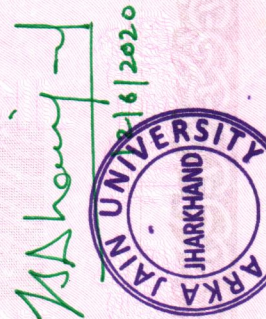

## Terms & Conditions

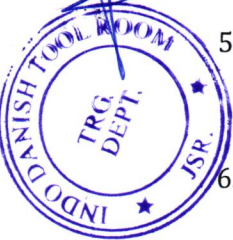
There as AJU & IDTR desirous to inter into an engagement of mutually acceptable fee to further the objectives for which the board base terms of reference are as follow.

## Scope and Terms of Reference of The Academic Agreement:

1. Venue of training: IDTR shall impart short term/ Medium Term/ long term Training/skill Development programs. For NSQF programs the venue of training shall be IDTR-Jamshedpur only. However, for non NSQF courses the venue may be mutually decided based On logistic & necessary infrastructure made available to run the course.
2. For Non NSQF courses the exciting curriculum of IDTR may be followed or course curriculum may be tailors made to meet the specific training requirement of CSE as mutually agreed between AJU & IDTR.
3. IDTR shall impart specialized training for the faculty improvement as per the curriculum designed by IDTR with inputs from AJU, IDTR will also provide the resource person for faculty development programs related to different courses for faculties and Industrial persons at AJU of specified duration as mutually agreed between AJU & IDTR.
4. All the courses shall be conducted by IDTR and certificate will be issued to the students/faculties/staff by IDTR on successful completion of the training programme as per the IDTR guidelines.
5. AJU & IDTR shall endeavor to enhance the number of training hours, no of the student trained, quality of the training, latest advancement in related technology based on the current and future global industry needs and the skill and knowledge required for the same.
6. AJU & IDTR shall endeavor to prepare an annual training calendar based on the training requirements for enhancing skill, technology, Employability and Entrepreneurship of the Students. The basic calendar may be improved upon with time and identification of newer and relevant industry requirements. IDTR conduct a host of skill development programs both short terms & long terms. The list of standard training programs is available on website [www.idtr.ov.in](http://www.idtr.ov.in) and its regularly updated.
7. AJU & IDTR shall both nominate their Nodal officer to coordinate/oversee the training related activities like courses schedule, courses content, course duration, faculty, admin, venue, teaching aids, commercial etc. for the smooth & successful implementation of the business agreement.
8. IDTR shall train the students on industry specific topic and give them projects for three months on the technologies in which the student is trained. The fee of project will be mutually decided by IDTR and AJU.
9. IDTR is a State of art Technology Centre and has several live projects and orders from reputed national and international customers. IDTR over the years has established itself as a Centre of Excellence for Design, Prototyping and Manufacturing of the complex requirements of national and international clients in the technological space. of AJU will hence get an opportunity to see and learn the application of the latest technologies and global best practices.

10. The fees of the training programmes shall be mutually decided based on the relevant factors and considering the long term objectives of the Business Agreement.

#### **Responsibility of IDTR:-**

1. Experienced Instructors/ faculty required for smooth conduct of the training shall be provided by IDTR.
2. Course Materials/ Curriculum required for the training shall be provided by IDTR
3. A Senior Faculty Member shall be in-charge for imparting of quality training/ successful completion of the training.
4. IDTR will assist to the extent possible in providing placement opportunities to the students who have been certified by IDTR. May be given, but it is not a mandatory clause for the agreement.

#### **Responsibility of AJU: -**

- AJU would provide Lab, Computers and other required facilities inside their campus for the courses being conducted by IDTR at AJU. For courses where it is mutually agreed to conduct the training at a venue other than AJU Campus, it will be the responsibility of AJU to provide all the necessary infra at their cost
2. AJU shall provide the Software and Machines as may be required at their campus for the specific training programme.
  3. AJU shall plan the Skill/ Technology/Entrepreneurship training for their students in consultation with IDTR and ensure that the students as planned are available for the entire duration of the training programme.
  4. AJU will allow all of its students to go through the training provided by IDTR.

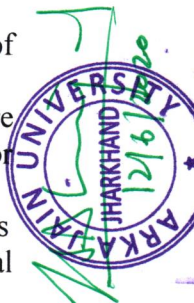
#### **General Agreement: -**

4. This Agreement may not be amended without the prior written consent of both the parties
5. The duration of the Business Agreement is for One Year and may be renewed on mutual agreement.
6. Termination: Either party can cancel or terminate this Agreement unilaterally without reason), by giving an advance notice of 1 month to the other.
