He worked as Principal Judge, Family Courts during February, 2014 till December, 2014. Further he was appointed as District & Sessions Judge of North East District, Karkardooma Courts, Delhi for about a month in December, 2014 and East District from January, 2015 to May, 2017. He was appointed as District & Sessions Judge (Headquarters), Tis Hazari Courts, Delhi in May, 2017 and served till 26th May, 2019. He was elevated as Judge, Delhi High Court on 27th May, 2019.

He also authored several books and papers such as “District Courts Case Management Manual for Judges” in 2005. Another book, “District Courts User’s Manual for Lawyers & Litigants” in 2006. The “Annual Reports of Delhi District Courts from 2003 to 2008”.
