#### **PLACEMENT POLICY:**

- 01. For every stream students we would follow One-Student One-Job Policy. Once a student is PLACED, he/she would not be allowed to participate in the forthcoming Placement drives.
- **02.** A student is considered to be "PLACED" once the organization announces the final result and accordingly his/her name features in the final result. There are various ways through which organizations confirm the selection of candidates. This could either be by publishing/sharing the result of selected candidate(s) by a letter, e-mail etc. or by sharing soft/physical copy of the candidate's Offer Letter/Selection Letter. In all such cases where the student's name features in the result of selected candidates or an offer letter/selection letter is issued, the student will be considered to have secured the Offer and PLACED with the concerned organization.
- **03.** The Training and Placement department is the only source of contact and sharing information pertaining to all the placement drives.
- 04. The organizations would share the result of selected students and send the Offer letters/selection letters/E-Mails to the Training & Placement Department.
- **05**. No student is allowed to communicate directly with the companies& visiting/engaging with the University for the Placement Drive until he/she gets placed with the particular organization or with a formal approval from the T&P Department.
