Faculty Curriculum feedback Survey was conducted in order to argument the Quality of the program . Survey questionnaire was prepared considering 15 major aspects

Overall Findings of Faculty Feedback on Curriculum and **University Programme**



Feedback on overall Curriculum

- 88% either agreed or strongly agreed that syllabi is appropriate to programme/courses
- 98% either agreed or strongly agreed that Courses are significant in terms of knowledge, concepts, manual skill, analytical abilities, Academia-Industry linkage and broadening perspectives
- 100% believed that Programme contents satisfy the vision and mission of the university
- 95% agrees that Credit allocation to each course is appropriate
- 100% faculty believes that course objectives and course outcome has significant learning outcomes
- 95% either agreed or strongly agreed that Practical courses enable students to acquire analytical/ experimental skills and to design and solve problems
- 94% either agreed or strongly agreed that the course content is well supported by relevant reference and book materials
- 77% agrees that Availability and accessibility of reference books/textual reading materials in the Department/ University Library
- 74% believes that availability and accessibility of additional source material (library e-learning materials)

- 100% either agreed or strongly agreed that On-time coverage of the prescribed syllabus is possible within the allotted hours
- 100% believes that Continuous Assessment Tests and semester examinations are conducted regularly well in time with proper coverage of all units in the syllabus
- 92% believes that there is a freedom to propose, modify, suggest and incorporate new topics in the syllabus
- 94% believes that there is freedom to adopt new techniques/strategies of teaching

Major Improvement Areas identified as Outcome of Faculty Curriculum Feedback



Committee constituted for analysis of Faculty Feedback have identified and recommended following key improvement areas:

Improvement Area: 77% agrees that Availability and accessibility of reference books/textual reading materials in the Department/ **University Library**

Committee has recommended to further strengthen the resources of the library. It was recommended that individual dean/ HODs of the school to assess the availability of reference books / textual reading material and submit proposal for purchase. It was decided to suggest Dean / HODs od the school to include sufficient number of reputed National / international Journal in their recommendation

Improvement Area: 74% believes that availability and accessibility of additional source material (library e-learning materials)

Committee has recommended to increase the availability of E-Learning material. Dean/HODs will be asked to include the list of e-resources in their purchase request. Committee has recommended make everyone aware of available MOOC courses facility in the library. It is also recommended to increase the number of computers for users usage and their access to E-Learning. It was recommended to put up a list of available E-Resources on Library Notice board. It is also recommended that any new arrival of books/Journal/e Journal should be notified to all the staff by email

Committee has recommended IQAC cell to present action taken report on above recommendation in the quarterly IQAC cell meeting
