**NOTICE FOR ALL 1<sup>st</sup> Year STUDENTS BATCH 2021**

**(Except D. Pharmacy. B.Tech & Diploma in Engineering)**

This is to inform all the 1<sup>st</sup> Year students batch 2021 that by abiding the guidelines of the Govt. of Jharkhand, offline classes will commence from 1<sup>st</sup> December 2021. Students need to follow the following guidelines as mentioned below.

- Beyond class room timing, students are not allowed to stay in the campus.
- It is mandatory for all the students to keep their COVID vaccination certificate soft copy or hardcopy with them, to show whenever asked for.
- ID card is mandatory and in no case students will be allowed in the campus without card. Students not having their card may collect the same from Registrar Office at the campus and only after obtaining their ID card, they will be allowed in the campus.
- Uniform is compulsory on Monday & Tuesday. After 31st December 2021, No student will be allowed without uniform inside the campus.
- Four wheeler parking is not allowed for students in the campus
- Two wheeler entry will be allowed from Gate no 3. And after parking the students have to enter from Gate no 2 by following the Covid-19 protocols. (Thermal Scanning, Register Entry and ID card checking).
- Transport facility for the students of 1st Year will start from 1st December 2021, for which students can apply by filling the transportation application form and can submit the same at Registrar office at campus. Transport application form is also available on the University website <https://arkajainuniversity.ac.in/academics/forms-formats/>. The notice of the same is being attached for your reference.
- For opting hostel facility (Optional) refer the notice attached below for your reference.

- Students are advised to bring their own mask (3 Layered N95) in adequate numbers, hand sanitizers, plates, spoons and tumblers.

**NOTICE TO 1st YEAR STUDENT FOR OPTING HOSTEL FACILITY**

This is to inform all the students that those who all are interested for opting Hostel Facility for the Academic Year 2021-22 need submit the hostel security money with the duly filled Hostel Application Form by 15th November 2021.

1. Hostel will reopen from the day offline classes will start
2. Student wish to opt for hostel facility need to fill the Hostel application form.
3. Please note the hostel fees applicable for Non AC 6500/- and AC 8000/- per month applicable from when the students joins the Hostel.
4. Student need to go through all the terms & Conditions / Rules & Regulation properly before filling the Hostel Application form.
5. In case of closure of hostel due to govt. imposed lockdown, and student wish to retain the hostel room. Student will be liable to Pay Rs-2500/-per month during the period of lockdown alternatively, student may vacate the hostel in case of lockdown.
6. Student wish to avail the hostel facility, will have to submit (-)ve RT-PCR report not older than 3 days or 72 hours from the day, they wish to start their stay in the hostel.
7. All student will also submit a COVID-19 declaration form attached with the hostel form.
8. Student will get the hostel only from the day offline classes will start.
9. Hostel form will be submitted only in the registrar office at campus. In no case, hostel application form will be accepted in the city office. Online hostel application form can be send to [studentsupport@arkajainuniversity.ac.in](mailto:studentsupport@arkajainuniversity.ac.in)
10. 1st day check-in time to the hostel will be only between 9.00 am to 6.00 pm. Please inform hostel in-charge Mr. Subodh Kumar (8789297008) a day before arrival.
11. Every student submitting hostel application form , will receive a hostel & room allotment letter. after depositing the hostel security amount of Rs 10000/- Non- AC & 20000 for AC .  
**Note:- Student will deposit the Hostel Fees & Hostel Security deposit after receiving the notice from the university.**
12. Its compulsory to bring hostel allotment letter on the 1st day of your arrival at hostel. You have to produce hostel allotment letter to the hostel- in-charge.
13. To Avail the transportation facility, student must follow the transportation notice issued from time to time or contact registrar office at 1<sup>st</sup> floor of Block A in the campus.

**Note :-Calculation of month will start from the date of allotment letter of the Hostel, not the date of Joining the hostel.**

2. Transportation fees will start and charged on Pro- Rata basis only from the month when offline classes Starts.
3. In case any order from government to stop the operation of Buses, due to adverse COVID 19 situation , fees paid for the transportation will be adjusted in the next year transport fees/ semester fees after deducting nominal amount of Rs 250/month. Under no circumstances transportation fees ones paid will be refunded (of the duration of Lockdown)
4. Transport facility is optional and not compulsory
5. Last date of submission of transportation form is 09.10.2021
6. Transportation will be made available from When the offline classes starts
7. Student must paste one passport size coloured photograph in the application form.
8. On or before 09.10.2021, students are instructed to submit the form and Transport fees Rs 5000/- at Registrar office @ campus or email the Form with Payment receipt at [studentsupport@arkajainuniversity.ac.in](mailto:studentsupport@arkajainuniversity.ac.in)
9. Transportation facility once opted is applicable for one full academic year & cannot be cancelled in between, irrespective of usage of the facility.
