Plagerism comes in many forms, some more severe than others— These are the five most common types of plagiarism:

- Global plagiarism means passing off an entire text by someone else as your own work.
- Verbatim plagiarism means directly copying someone else’s words.
- Paraphrasing plagiarism means rephrasing someone else’s ideas to present them as your own.

- Patchwork plagiarism means stitching together parts of different sources to create your text.
- Self-plagiarism means recycling your own past work.

Students were also explained about the various scholarship programmes.

It was also said to the students to build up such a great C.V which can't be denied. By mentioning about the various legal research and other activities of law school.

To be a good lawyer one must have writing skill. By writing various articles, participating in conferences, moot court, debate and legal research can enhance their C.V and to be a good Lawyer.
