The aforesaid institutes are hereinafter referred to individually as "institute" and collectively as "institutes"

About the Parties to MOU

National IAS Academy:

Academy operates with a Vision to "To nurture young minds, provide continuous guidance and support through technology, team-work and innovation and to assist aspirants associated with us to accomplish their dream and participate in the progress and development of the Nation".

JAIN (Deemed-to-be University):

JAIN, currently engaged in engineering education leading to B. Tech, M. Tech & Ph. D degrees and education in other disciplines such as Management, Commerce, Humanities & Social Science, Pure and Applied Sciences.

1. Objective of MoU

To provide coaching to UPSC - Civil Services Examination aspirants.

2. Responsibility Sharing

As per this MoU "Academy" and "Jain "agree to share the following responsibilities for achieving the above said objective.

- A) As per this MoU, Academy will provide
 - i. Highly efficient faculty to teach the Aspirants for UPSC Civil Services Examination.
 - ii. Completion of UPSC-Civil services examination syllabus by conducting 500 Hours of classes.
 - iii. Providing the study material to the aspirants.
 - iv. Regular assignments to aspirants.
 - v. Answer writing practice.
 - vi. Conducting regular class tests.

- vii. Evaluation and feedback to answer papers.
- viii. Interview guidance.
- ix. Personal attention to the aspirants by assessing the weekly/monthly evaluation of aspirant performance.

B) As per this MoU, "Jain" will provide -

- i. Class rooms for conducting classes.
- ii. Projector, white board, sound and light system.
- iii. Office space for Academy.

3. Coaching charge

- a) Coaching includes training for Prelims, Mains and Interview stages of the exam along with Test Series practice, which spans across 2 or 3 years according to their completion of Graduation/ Post Graduation.
- b) Mentorship and counseling support services shall be provided till the candidate clears the exam.
- c) An amount of Rs.1,00,000/- (Rs. One Lakh only) shall be collected by the Academy for each student and Academy shall pay Rs.10,000/- (Rupees Ten Thousand only) for each student as rentals for using our facilities.

4. Confidentiality:

- a) Both "Academy" and "Jain "agree to hold in confidence all information and data designated by the "institutes" as being confidential which is obtained from either "institute" or created during the performance of the MoU and will not disclose the same to any third party without written consent of the other "institute".
- b) The above confidential clause under this MoU excludes the information/data processed by either "institute" before entering into this MoU or independently developed and/or information already available through public domain.

5. Duration of MoU

This MoU will be operational and valid for **3 years** from the date of signing.

This MoU, unless extended by mutual written consent of the "institutes" shall expire on completion of the UPSC-Civil Services Examination coaching for any upcoming batches on or before 31st July 2024.

6. Coordination

Both institutes will designate persons who will have responsibility for coordination and implementation of this MoU.

7. Revenue sharing

a) Ten percent of the revenue accrued in every academic year shall be shared with the Jain (Deemed to-be University) effective as on today.





8. Dispute Resolution

a) "In the event of a dispute, controversy or claim arising out of or relating to this Memorandum of Understanding, or the breach, termination or invalidity thereof (a "dispute"), the Parties will use their best efforts to settle promptly such dispute through direct negotiation.

If any dispute arises between National IAS Academy and Jain (Deemed-to-be University) on the operation and execution of the agreement, efforts shall be made to resolve the same amicably and if the dispute is not mutually settled, then it shall be refined for resolution between the Management of Jain (Deemed-to-be University) and National IAS Academy. The Courts in Bengaluru will have the jurisdiction in case of any dispute.
