

9. Modifications- This agreement may not be modified or amended except by a written agreement that refers to this agreement and is signed by both parties hereto.

10. Governing Law / Jurisdiction- This agreement shall be governed by and construed in accordance to the exclusive jurisdiction of the Courts of Bengaluru, Karnataka, India.


