Memorandum of Understanding

This Memorandum of Understanding is signed on December 20th, 2016 by and between

Hachiko Technologies Private Limited, owner of **CampusTime** hereafter referred to as 'Company'

and

Purpose

This MOU is signed to establish an agreement between Company & JU that allows:

Company to launch, maintain & upgrade the Campus Time App for the JU

CampusTime comprises of the following for the JU:

- App for the JU and its Students & Faculty
- Backend Cloud Based Admin System for the Campus Admin

The above goal will be accomplished by undertaking the following activities:

- 1. JU agrees to use CampusTime app as its official communication platform
- 2. JU agrees that its students, faculty and admin staff will fully cooperate with company so as to ensure successful implementation and continuous usage of the app
- 3. JU will provide its Logo and description details to the Company
- 4. JU will provide the data of the students & staff in the format specified by the company that includes registration no. of the students, first name, last name, course, department, section, batch, employee ID in case of faculty & admin staff, their qualification post and mobile number, email ID that are optional fields
- 5. This data will be ported to the system by the company
- 6. Company will prepare the application to be ready for the launch
- 7. JU will assign a campus admin who will be accessing & posting all the updates through the app and the admin console. The campus admin will be the single point of contact for the company and will work closely with the company in ensuring the successful running of the app
- 8. Company will provision the web based admin console on Cloud and provide secure access to the campus admin and authorized users at JU
- 9. JU will have its students and faculty download the app
- 10. Users of the JU will start using the app
- 11. Company will work with campus abokis (student volunteers) and train them to use the application. These student volunteers will be identified by the JU and provide permission to work closely with the Company





- 12. Company may introduce new features and may cut down some features on the App from time to time without being required to seek any further approval or intimating the JU or users in this regard. The Company may launch the app to support other devices in the future.
- 13. Any data generated during the tenure of this service shall belong to the respective user. This is governed by the company's terms & privacy policy
- 14. Any Intellectual Property created / generated with respect to the product during the course of this agreement shall belong solely to the Company and the JU shall have no right on the same whatsoever
- 15. The usage of the app by its users and partner University will follow the privacy policy and terms:

Funding

CampusTime is being provided to JU for FREE. The app is free for the JU, its students and faculty. The web based admin console is also free for the JU.

JU agrees that the Company is free to generate its revenues through other monetization channels like job posts, advertisements, transactions etc. through parallel use of the app. The Company is not obliged to share any such revenue generated through the parallel use of this app with the JU.

The Company does not guarantee any specific outcomes to the JU or its user through the use of this app and shall be in no way responsible for any unauthorized actions or misuse of the same.

In case the JU needs custom services from the Company, funding will be required for such specific additional services as will be mutually agreed.

Exclusivity





The JU confirms that it shall only work with the Company exclusively to implement the App for its use and will not partner with any other firm/ app developer that might be of conflict of interest to the Company

Confidentiality

Company agrees to keep all the data of the JU & content posted by the users of the JU confidential at all times and no one else apart from the registered users of JU will be able to access the content. Both Company and JU also agree that both will take all reasonable measures to maintain the confidentiality of all confidential information of the other Party in its possession or control.

Duration

This MOU is at-will and may be modified / terminated / renewed by mutual consent of authorized officials from Company & JU. This MOU shall become effective upon signature by the authorized officials from the Company & JU and will remain in effect until modified or terminated by any one of the partners by mutual consent.
