viz. **Shreshtha Netra Chikitsalaya, Dhanbad (Party-2).** located at Urmila Enclave, Ground Floor, Main Road Saraidhela Dhanbad-828127.

- 1. ARKA JAIN University (AJU) will send students (as per the discussion via mail or Call) of B. Optometry (Final year students) for Internship from June / July (every session), which will be for 11 months (April / May).
- 2. Posted intern will be benefitted monthly **Rs Seven thousand** only (Rs 7000) as Internship.
- 3. Final year Internship will be decided by AJU & Students freely.
- 4. Absorption / Employment for students will be secured by Shreshtha Netra Chikitsalaya (As per requirement).
- 5. AJU will provide skill improvement short term program for Staff of Shreshtha Netra Chikitsalaya (certificate will be handed to Shreshtha Netra Chikitsalaya)
- 6. Faculty exchange will be done as per availability of Ophthalmologist/Optometrist (Subject expert).



- For aforementioned points there will not be any beneficial transaction in cash or kind for Any Parties.
- 8. Period of validity of this Agreement is initially for 5 years from the date of signing which can be renewed by mutual consent of both parties.
- 9. Arbitration Any Dispute arising with regard to any aspect of this agreement shall be settled through mutual consultations and agreements.

10. Both the parties are free to discontinue the agreement with prior information of one month.
