The University is government recognized university with the right to confer degree as per the section 2(f) and 22 (1) of the UGC Act, 1956 having its corporate office at D-28, Danish Arcade, Opp. Asian Inn Hotel Dhatkidih, Jamshedpur-831001 and campus at Mohanpur, Opp. Kerala Public School, Gamharia, Dist - Seraikela Kharsawan, Jharkhand -832108, represented by its Registrar, **Dr. Amit Kumar Shrivastava**, (herein after referred to as the "ARKA JAIN University" or the "**FIRST PARTY**" which expression shall include its successors and assigns) for the purpose of undertaking collaborative activities.

AND

AMYA Polytechnic College, INC Tulip Drive, Ecoland, Davao City, Philippines is the educational subsidiary of the AMYA Foundation, Inc., founded in 1987 by the late educator, philanthropist Dr. Aurea Mercado Y Adrias, PhD (AMYA). AMYA Polytechnic College is herein represented by the President Mary Ann Concepcion C. Pia, RN, MAN hereby referred to as "**SECOND PARTY**."

ARKA JAIN University, Jharkhand and **AMYA Polytechnic College, Philippines** are hereinafter jointly referred to as the "**Parties**" and individually as the "Party".

It is run by a Board of trustees representing several Davao City - based institutions personally chosen by Dra. AMYA to serve on the Board. With its motto "Empowering the Unskilled", several projects and initiatives have been established to carry on its purpose in the fields of agriculture, education, and culture. AMYA Polytechnic College opens this year as the academic service arm of the AMYA Foundation. It offers a senior high school (SHS) program focusing on Academic, TVL Tracks and college programs namely; Bachelor of Science in Medical Laboratory Science, Bachelor of Science in Pharmacy, Bachelor of Science in Radiologic Technology, and Bachelor of Science in Tourism Management. From its modest beginning 32 years ago, AMYA Foundation looks to grow and continue the vision and mission of Dr. Mercado Y Adrias. Amya Polytechnic College plays an important and integral part in the Foundation's mission as it endeavors to provide quality education for its community.
- III. The Parties have appreciated each other's objectives in promoting Excellence inter alia in common area of interest, imparting knowledge and skills required to operate in the area of Academic, Research and Training and are desirous of putting the broad terms of the intentions into a Memorandum of Understanding (MOU) for the areas identified for co-operation and commit to co-operate to the fullest extent by mutual understanding.

- IV. This MOU is subject to the approval of the respective Statutory Authorities of the parties here to and subject to changes as may be desired.
- V. The autonomy of each party shall not be diminished, nor constraints be imposed on to carry out the MOU.
- VI. The development and implementation of specific forms of cooperation based on this MOU will be separately established/ decided between parties and outlined in executive protocols, specifying the nature of joint activities, financial and other arrangements.

NOW THE MEMORANDUM OF UNDERSTANDING WITNESSETH AS FOLLOWS:

- I. Both the Parties have hereto identified the following areas where they agree to mutually cooperate to the fullest extent:
- Workshop/ Seminar and Conference/Virtual exchange of Classes/Faculty Exchange Program Virtually: **AMYA Polytechnic College** or **ARKA JAIN University** could participate as Faculty / Speaker Workshops, Seminars, Continuing Education and Training programmes conducted by both parties for Faculty Members, Research Scholars and students.
 - Both parties agree to undertake students and involved them for Joint Research Projects which are mutually beneficial. However selected M. Pharm/U.G. students will get opportunity to pursue their research projects at the virtual guidance of **AMYA Polytechnic College**.
 - Extend help and Co-operation in developing Curriculum of Continuing Education Programmes, on such terms as may be mutually agreed to including Joint Meeting of Curriculum Development Committees / bodies.
 - Both parties** will take selected students of Pharmacy for / Internship training every year with the students as agreed mutually by the parties.
 - Absorption / Employment for the students will be purely on the discretion of **both parties** (As per their requirement).
 - Students of **Both Parties** if interested can enroll for the pharmacy course run by both parties by fulfilling their admission norms at fee structure mutually agreed by the parties and the standards set by their Pharmacy Board and other governmental agencies.

II. Faculty Development Programmes:

Faculty Development Programs are an essential component in standardizing the Class room teaching all over the country. III. Non-Binding Nature of the MOU

Nothing in this MOU shall be construed as creating any contract, partnership, agency or other legal relationship between the parties. The acts/performance and actions taken by either party in furtherance of their respective activities of operation shall not bind the other except to the extent provided under this MOU. The acts performed and action taken by either party that do not fall under the MOU shall have binding effect on the other to the extent they are reduced to writing and the prior consent of the other party is obtained. Also, the MOU does not restrain or preclude parties from entering into similar MOUs with any other organization during currency or the extended currency of this MOU.

IV. Terms and Termination of the MOU

The MOU shall come into force immediately upon its signing by the parties. The MOU will be in force for an initial period of five (5) years. MOU may be extended further on the mutually agreed terms. ARKA JAIN University or AMYA Polytechnic College shall not have any right to claim extension or renewal of contract.

- a. This MOU may be terminated by mutual consent of the parties before the aforesaid term of five (5) years.
- b. This MOU can also be terminated by either of the parties by giving advance notice of three (3) months period without jeopardizing the ongoing collaborative undertakings.
- c. The implementation and/or continuance of programmes or project established pursuant to this MOU prior to the effective date of termination shall not be affected by the termination of this MOU.

If any provision of this MOU is held invalid, unenforceable or illegal for any reason, this MOU will remain otherwise in full force apart from that provision(s) which shall be deemed deleted.

VII. Assignment & Sub-Letting

Neither party shall assign or sub-let any of its rights and obligations hereunder whether in whole or in part without the prior written consent of the other.

VIII. Confidentiality

Both Parties agree to treat the contents of this MOU and any valuable information provided, developed, found or acquired in the process or performance of this MOU, as confidential and agree and undertake that the Parties shall not disclose the contents of the same to any third party without the prior consent of the other Party unless such information is required to be disclosed under the applicable law, or in pursuance of the order of a competent court, tribunal or other regulatory authority exercising valid jurisdiction. In such case of disclosure of confidential information, the disclosing party shall promptly notify the other party in writing of such disclosure.

For purposes of this MOU, "Confidential Information" includes information that: (i) is sufficiently secret to derive economic value, actual or potential, from not being generally known to other persons who can obtain economic value from its disclosure or use; and / or (ii) is the subject of efforts that are reasonable under the circumstances to maintain its secrecy or confidentiality.
