COMPANY PROFILE:

Tata Consultancy Services (TCS) is an Indian multinational information technology (IT) services and consulting company headquartered in Mumbai, Maharashtra, India with its largest campus located in Chennai, Tamil Nadu, India. As of February 2021, TCS is the largest IT services company in the world by market capitalization (**\$200 billion**). It is a subsidiary of the Tata Group and operates in **149 locations across 46 countries**.

TCS is the second largest Indian company by market capitalization and is among the most valuable IT services brands worldwide. **In 2015, TCS was ranked 64th overall in the Forbes World's Most Innovative Companies ranking, making it both the highest-ranked IT services company and the top company.** As of 2018, it is ranked eleventh on the Fortune India 500 list. In April 2018, TCS became the first Indian IT company to reach \$100 billion in market capitalisation and second Indian company ever (after Reliance Industries achieved it in 2007) after its market capitalisation stood at ₹6.793 trillion (equivalent to ₹7.3 trillion or US\$100 billion in 2019) on the Bombay Stock Exchange. In 2016–2017, parent company Tata Sons owned 72.05% of TCS and more than 70% of Tata Sons' dividends were generated by TCS. In March 2018, Tata Sons decided to sell stocks of TCS worth \$1.25 billion in a bulk deal. **As of 15 September 2021, TCS has recorded a market capitalization of US\$200 billion, making it the first Indian IT firm to do so.**

Test Eligibility:

Percentage: Candidates should have a minimum aggregate (All subjects in all semesters) of 60% or equivalent CGPA in class 10th, 12th, Diploma (if applicable), graduation, and post-graduation examination.

Highest Qualification: Candidates pursuing full-time management post-graduate courses (MBA/MMS/PGDBA/PGDM) offered by a recognized university with specializations in Marketing/Finance/Operations/Supply Chain Management/Information Technology/General Management/Business Analytics/Project Management or related disciplines offered by recognized University/College will be considered from Year of passing (YoP) 2023 & 2024.

Graduation Background: Any graduate degree from a recognized University/College would be considered eligible.

Backlogs / Arrears / ATKT: The candidate should not have any pending backlogs.

Extended Education: No extended education would be allowed. Candidates should have completed the course in the stipulated course duration.

Gap / Break in Education: It is mandatory to declare gaps in education, if any. The overall academic gap should not exceed 24 months until the highest qualification. Relevant documentation, as applicable, will be checked for gaps in education.

Course Types: Only full-time courses will be considered (Part-time/Correspondence courses will not be considered).

Open Schooling: Candidates who have completed their Secondary and/or Senior Secondary course from NIOS (National Institute of Open Schooling) are also eligible to apply if the graduation and post-graduation (if applicable) courses are done full-time.

Work Experience: Candidates with prior work experience (Part-time/Full-time) of only up to 2 years are eligible to apply for the TCS MBA Off Campus Hiring Process. They need to mandatorily declare the same in the TCS application form. Candidates would be required to submit the necessary documents supporting this work experience at the time of the TCS selection process and post joining TCS, as per requirements.

Age: Candidates should be between 18 to 28 years to participate in this hiring event.

- Verbal Ability
- Numerical Ability
- Business Aptitude

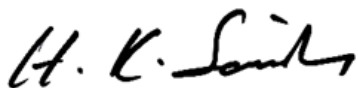
