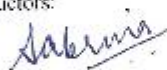

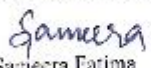

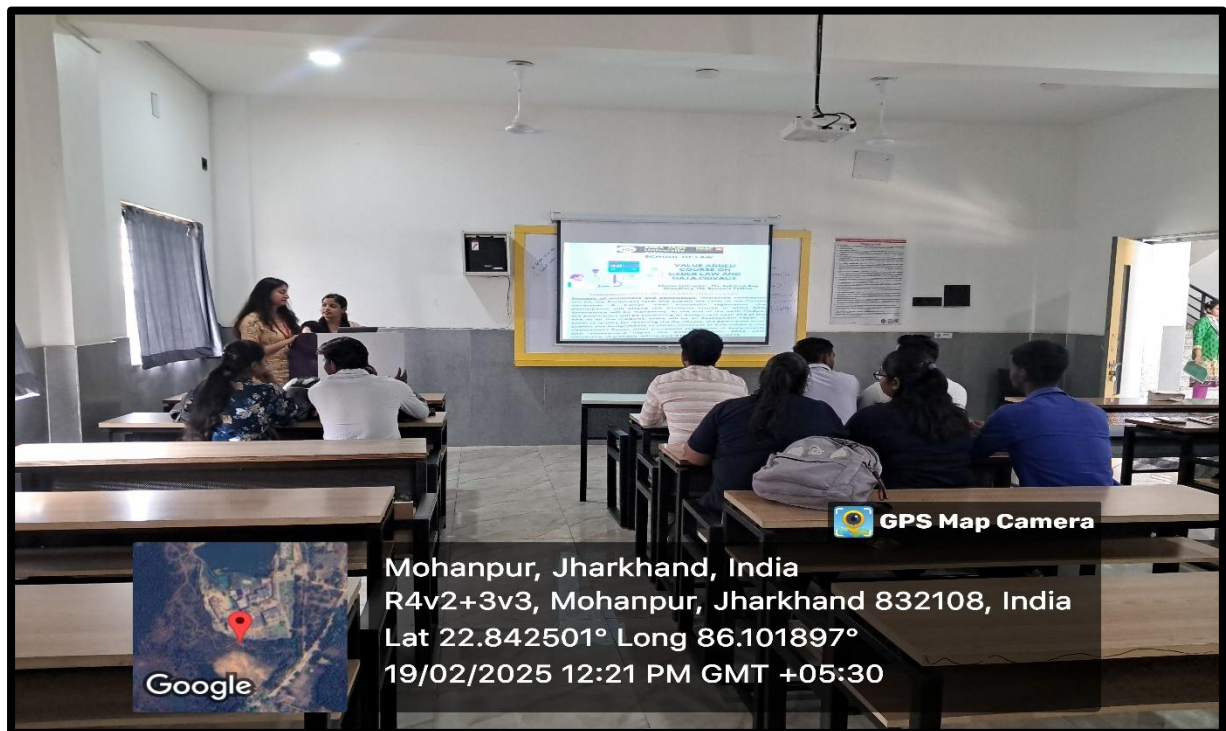


FIG.1- INTRODUCTORY OFFLINE VAC CLASS

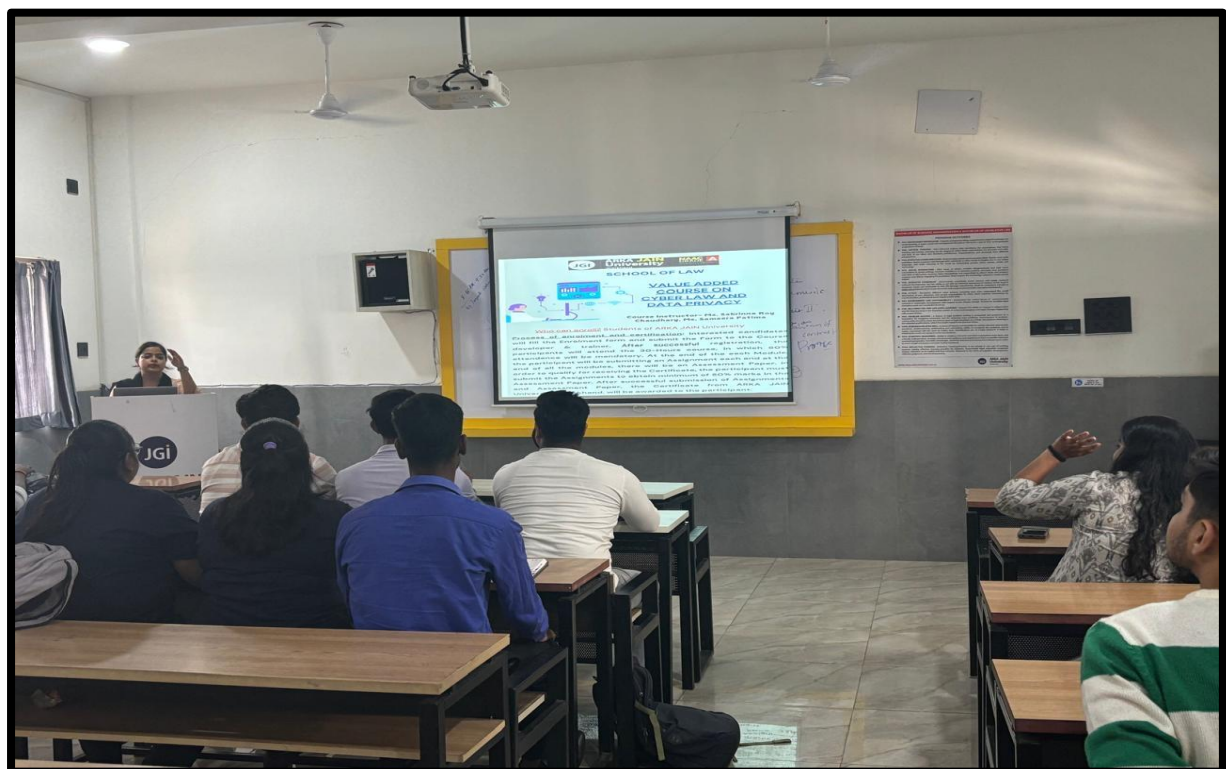


FIG. 2- OFFLINE VAC CLASS

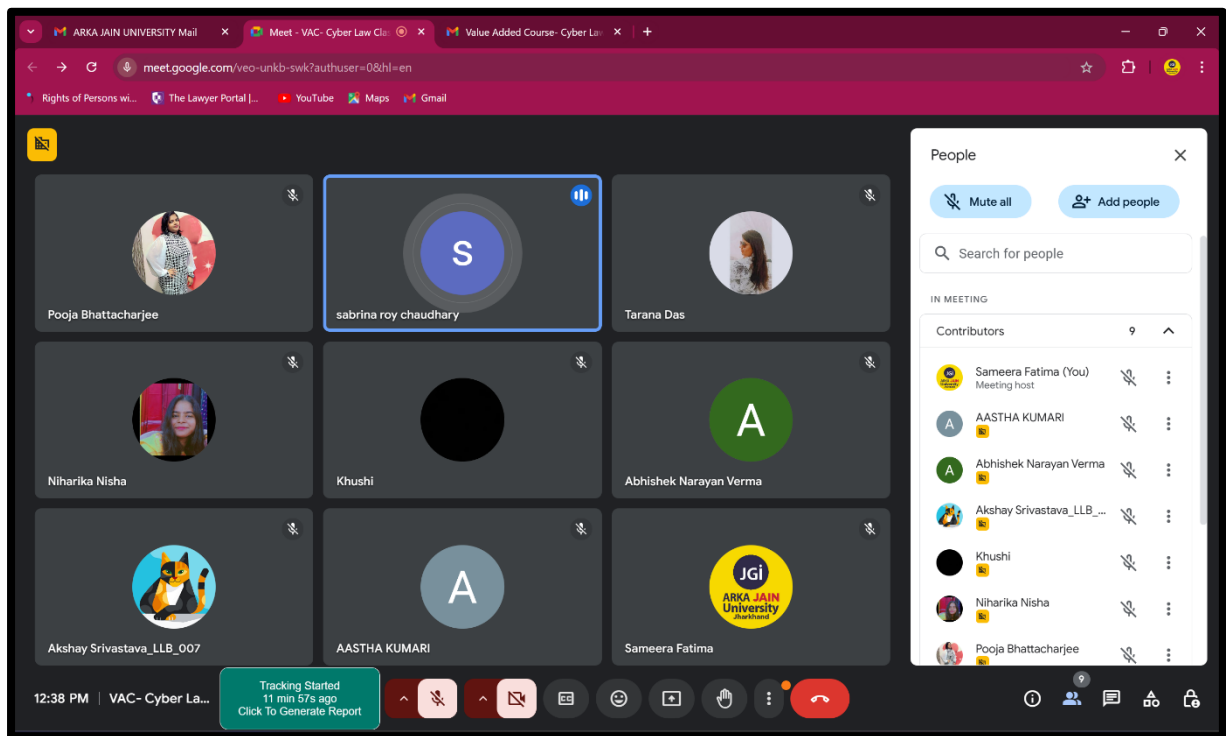


FIG.3-ONLINE VAC CLASS
