OBJECTIVE:

To equip students and professionals with a comprehensive understanding of the **Uniform Civil Code (UCC)** in the context of the **Indian Constitution**, to explore its implications for **national unity**, and to understand its role in upholding the **Rule of Law** and promoting **equality and justice**.

Key objectives include:

To understand the constitutional basis of the Uniform Civil Code (UCC), with specific reference to Article 44 and its place in the Directive Principles of State Policy.

To analyze the role of UCC in promoting national unity and integration by fostering a common set of civil laws for all citizens, irrespective of religion or personal belief.





To examine the relevance of UCC in strengthening the Rule of Law and ensuring equality before law for all individuals in a secular democracy.

To explore the tension between personal laws and Constitutional values such as secularism, gender justice, and individual rights.

To develop critical awareness of social and legal reforms linked to UCC and understand the implications of implementing a uniform code in a diverse society like India.

To enhance participants' capacity for legal reasoning and constitutional interpretation, particularly in the context of personal laws and civil rights.

DETAILS:

An Expert Lecture on LAW Day was organized by the school of Engineering & IT, ARKA, JAIN University on APRIL 24TH, 2025. The Expert Lecture aimed to provide participants with a comprehensive understanding of the Uniform Civil Code (UCC), highlighting its significance in promoting equality, justice, and national integration. The session covered a wide range of topics—from the constitutional foundations of the UCC to its implications for individual rights and social reform. The lecture also addressed current challenges and violations related to civil codes both in India and globally, emphasizing the need for legal uniformity and the protection of human rights.

Special focus was placed on the role of various stakeholders, including the judiciary, government, civil society, and academic institutions, in advocating for and implementing reforms. The event sought to create awareness among participants about the benefits and advantages of upholding human rights within a unified legal framework.


