Subject: Faculty Briefing on NPTEL Course Mapping and Credit Substitution Initiative

All faculty members of the department are hereby informed that, as per the directive issued by the **Registrar**, **ARKA JAIN University**, a structured initiative has been launched to promote active participation in **NPTEL courses** among students for the **July-December 2025 duration**.

The initiative aims to integrate relevant NPTEL courses into the academic framework by mapping them to internal curriculum subjects across the second, third, fourth, and fifth years (where applicable). First year is not applicable for the odd semester. However, for even semester, even first year would be considered.

The key points of the initiative are as follows:

This initiative aims to integrate relevant MOOCs into our academic framework and encourage students to take up courses that align with their academic progression.

Faculty are requested to familiarize themselves with the mapped courses and assist in effective implementation and student motivation.

Faculty Action Points:

- 1. Encourage students to register only for the above mapped NPTEL courses based on their year of study.
- 2. Inform students that successful completion of the NPTEL course (exam in October) will:
 - Earn them marks in the corresponding university course.
 - Grant exemption from the end-term exam of that subject.
- 3. Monitor registrations and support students with any technical or academic doubts.
- 4. Ensure that students who clear the NPTEL exam submit their certificate/marksheet to claim academic credit.
- 5. Note that students who do not register or fail the exam must appear for the endterm exam as usual.
- 6. This initiative, though not mandatory, should be actively implemented, as it contributes to key institutional metrics such as NAAC and other ranking frameworks.

BoS Ratification Required:

Please note that the mapped NPTEL courses must be formally ratified in the next Board of Studies (BoS) meeting, and documentation must be submitted.

Faculty members are requested to cooperate in identifying relevant courses, assisting with mapping, and actively guiding students throughout the process. This initiative reflects the university's commitment to academic excellence and outcome-based education.
