### OBJECTIVE:

The aim of the session was to disseminate knowledge on Pension Fund Investments.

**DETAILS:** The Department of MBA, School of Commerce and Management has organised a guest session on 'Pension Fund Investments'. The resource person of the session was Mr. Harendra Kumar, Sr. Manager, Head-Payroll Team, Tata Motors. During the session, Mr. Harendra provided an in-depth overview of Pension Fund Investments, its features and benefits. He explained about the NPS which is a government-sponsored retirement savings scheme aimed at ensuring financial security post-retirement. He made the participants aware about the key aspects of NPS such as eligibility, contribution methods, tax benefits, and the various asset classes available for investment. The participants were also introduced to the process of opening an NPS account, along with the option to choose between a Tier I and Tier II account. Emphasis was placed on the long-term nature of NPS as a reliable and cost-effective retirement planning tool. All the MBA Students attended the session actively. Prof. Dr. S. S. Razi, Chairperson Board of Management, Prof. Dr. Angad Tiwary, Dean, Student Welfare, Dr. Urvashi Thakur, Head, Department of MBA, Mr. Sailesh Kumar and Ms. Rana Iffat Perween, Department of Management were present during the session. 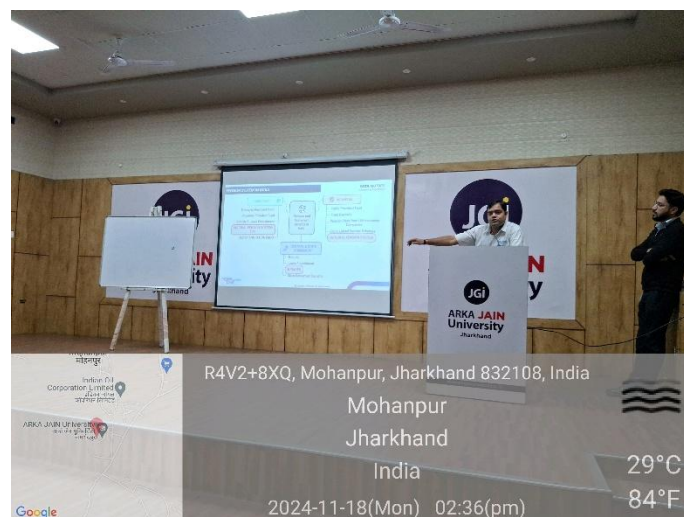


Fig. 2: Address by the guest

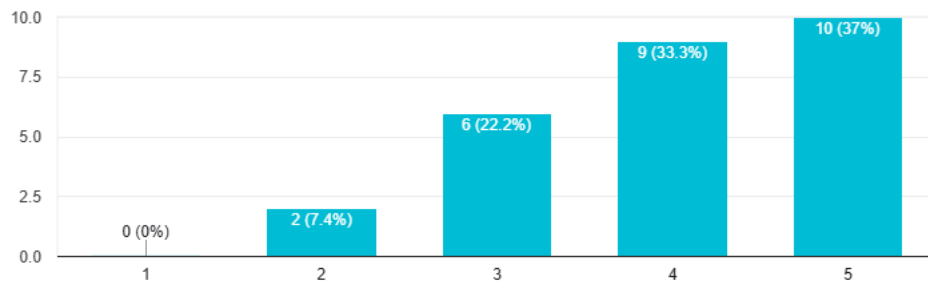




The resource person provided adequate time for questions and answered them satisfactorily.
