OBJECTIVE:

The objective of this programme is to train faculty members to precise, standardised, and legal documentation techniques. It aims to guarantee the fulfilment of academic and legal standards in administration, research, and guidance.

DETAILS:

School of Pharmacy, ARKA Jain University conducted a comprehensive faculty training session on Good Documentation Training on Writing of Reports. Expert for this training session was Prof (Dr.) Jyotirmaya Sahoo, Dean, School of Pharmacy. The training was held on 23rd July at **Block B, Sushruta Hall**, and began promptly at **9:30 AM**. The session was organized with the intention of strengthening the understanding and implementation of proper documentation protocols among faculty members.
