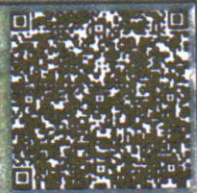

The **MEMORANDUM OF UNDERSTANDING** (hereinafter referred to as 'MoU') made at Bangalore, on **08-10-2024** between **ARKA JAIN UNIVERSITY** (hereinafter referred to as ARKA JAIN UNIVERSITY) on the ONE PART

AND

Consortium of National Law Universities, the sole authority for regulating the examination and for declaration of the results for CLAT-2025 (Common Law Admission Test), an All India Examination.

WHEREAS

- (i) **ARKA JAIN UNIVERSITY** desires to utilise the UG-CLAT 2025 Examination scores for the purpose of admission during the Academic Year 2025-26.
- (ii) Pursuant there to **ARKA JAIN UNIVERSITY** and the Convenor Consortium of National Law Universities have worked out certain arrangements, as noted in this MoU with a view to utilise the UG-CLAT 2025 Examination Score.
- (iii) The parties desire to record the terms and conditions and the objectives of the utilization of CLAT- 2025 scores and matters incidental thereto.

DEFINITIONS

The following expressions used herein shall, unless repugnant to the subject or context thereof, carry the meanings here under respectively assigned to them, namely;

- 1 "CLAT" shall mean the Common Law Admission Test.
- 2 "CLAT- 2025" shall mean the Common Law Admission Test conducted by the Consortium of National Law Universities for admissions to programmes commencing in the Academic Year 2025-2026.
- 2 "Actual CLAT marks" shall mean the marks (Out of 150) secured by the candidates who have appeared for the UG-CLAT 2025 Examination.

NOW, THEREFORE, THIS MoU WITNESSETH as follows:

- (a) The Consortium of National Law Universities shall provide ARKA JAIN UNIVERSITY a LOGIN ACCOUNT to a database that ARKA JAIN UNIVERSITY may use to verify the CLAT-2025 Marks, Qualifying Marks, All India Rank (AIR) and the contact details of individual candidates who have appeared for CLAT 2025 and who have consented to their details being shared with third parties.
- (b) The information derived from the database accessed through the above mentioned LOGIN ACCOUNT shall be used by **ARKA JAIN UNIVERSITY** only and it shall not be shared by **ARKA JAIN UNIVERSITY** with any other University / Institution / College / Agency.

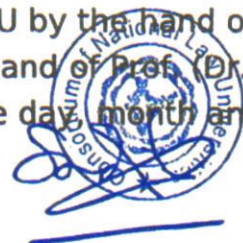

GST at 18% will be added to the invoice.
- (i) The **ARKA JAIN UNIVERSITY** will be required to pay an Annual Fee of **Rs.1,40,000.00/- Rupees One Lakh Forty Thousand only**. GST at 18% will be added to the invoice.
- (j) The Secretariat of the Consortium of National Law Universities will provide the above mentioned LOGIN ACCOUNT to access the details within 30 (Thirty) days of declaration of CLAT 2025 results, subject to payment in advance along with the MoU from **ARKA JAIN UNIVERSITY**

All the matters of dispute shall be subject to the jurisdiction of the Courts in Bangalore only. The parties shall use their best endeavours to settle any dispute or claim arising out of or relating to the MoU in supplemental agreements and their attachments thereto, amicably. If not amicably settled within 60 (Sixty) days of the dispute or claim arising, such dispute or claim shall be decided by a Sole Arbitrator to be appointed by the mutual consent of the parties in accordance with the provisions of the Indian Arbitration and Conciliation Act, 1996. The parties agree that the decisions of the Arbitrator so appointed shall be final and binding upon the parties. The venue for the Arbitration shall be Bangalore.
