The University is government recognized university with the right to confer degree as per the section 2(f) and 22 (1) of the UGC Act, 1956 having its corporate office at D-28, Danish Arcade, Opp. Asian Inn Hotel Dhatkidih, Jamshedpur-831001 and campus at Mohanpur, Opp. Kerala Public School, Gamharia, Dist-Seraikela Kharsawan, Jharkhand -832108.


ARKA JAIN University is accredited with Grade A in its First cycle by NAAC, Bengaluru, and represented by its **Registrar, Dr. Amit Kumar Shrivastava**, (herein after referred to as the “ARKA JAIN University” or the “FIRST PARTY” which expression shall include its successors and assigns) for the purpose of undertaking collaborative activities.

AND

Dr. Madhukarrao Wasnik PWS Arts, Commerce and Science College, Kamptee Road, Nagpur, represented by **Dr. Yeshwant Patil**, Principal, for the purpose of undertaking collaborative activities. 

WHEREAS:

- I. ARKA JAIN University** was established in February 2017 by the JHARKHAND State Legislature under "The ARKA JAIN University Act". The University is a government-recognized university with the right to confer degrees as per sections 2(f) and 22(l) of the UGC Act, 1956. The sprawling campus of the University is situated at Gamharia, Dist: Seraikela - Kharsawan, 13 km from steel city Jamshedpur. The University offers multi-disciplinary programs and intends to enter into an agreement in which they will work together to achieve the various aims and objectives relating to the academic, cultural, social, and holistic development of the students and society through collaborative endeavors undertaken by both institutes.
- II.** The Parties have appreciated each other's objectives in imparting knowledge and skills required to the students of B.A. English for their collaborative academic, social, and extension activities that aims to create opportunities for skill and employability development. The purpose of the Memorandum of Understanding (MOU) is to develop communication skills and Academic writing in the students with the involvement of Subject Matter Experts from both the organizations.
- III.** The proposed activities will be Expert Lecture Series, Seminar & Webinars, symposium, Conference, Literary activities, workshops, field works, field research, internship, skill-based courses, Faculty Development Program, joint publications, etc.
- IV.** This MOU aims to create Online and Blended learning, and promote outcome-based teaching and learning. To develop the communication skill language and literary studies of the students of both the organizations.
- V.** This MOU is subject to the approval of the respective Statutory Authorities of the parties hereto and subject to changes as may be desired.
- VI.** The autonomy of each party shall not be diminished, nor constraints be imposed on to carry out the MOU.
- VII.** The development and implementation of specific forms of cooperation based on this MOU will be separately established/ decided between parties and outlined in executive protocols, specifying the nature of joint activities, and other arrangements.

VIII. Non-Binding Nature of the MOU

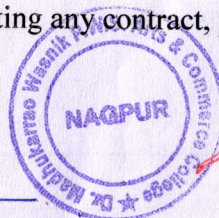
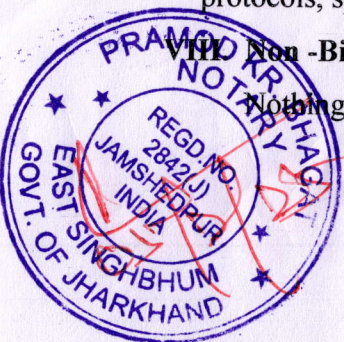
Nothing in this MOU shall be construed as creating any contract, partnership, agency or

other legal relationship between the parties. The acts/performance and actions taken by either party in furtherance of their respective activities of operation shall not bind the other except to the extent provided under this MOU. The acts performed and action taken by either party that do not fall under the MOU shall have binding effect on the other to the extent they are reduced to writing and the prior consent of the other party is obtained. Also, the MOU does not restrain or preclude parties from entering into similar MOUs with any other organization during currency or the extended currency of this MOU.

IX. Terms and Termination of the MOU

The MOU shall come into force immediately upon its signing by the parties. The MOU will be in force for an initial period of five (5) years. MOU may be extended further on the mutually agreed terms. "ARKAJAIN University" and "Dr. Madhukarrao Wasnik PWS Arts, Commerce and Science College, Kamptee Road, Nagpur" shall not have any right to claim extension or renewal of contract.

- a. This MOU may be terminated by mutual consent of the parties before the aforesaid term of five (5) years.
- b. This MOU can also be terminated by either of the parties by giving advance notice of one (1) month period without jeopardizing the ongoing collaborative undertakings.
- c. The implementation and/or continuance of programs or project established pursuant to this MOU prior to the effective date of termination shall not be affected by the termination of this MOU.

X. Amendments

No change, alteration or modification of this MOU shall be valid, unless in writing and signed by both the Parties hereto.

XI. Severability

If any provision of this MOU is held invalid, unenforceable or illegal for any reason, this MOU will remain otherwise in full force apart from that provision(s) which shall be deemed deleted.

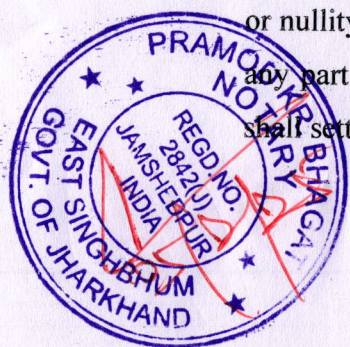

XIV. Governing Law

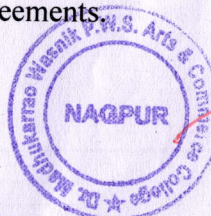
The MOU shall be interpreted in accordance with and governed by the applicable laws in India.
