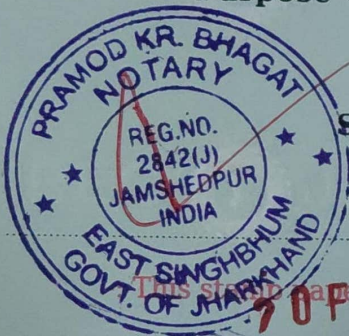

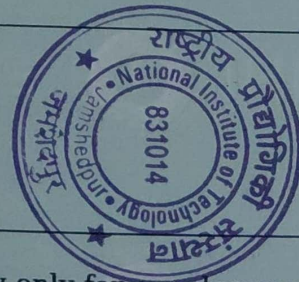

Article 3: ROLES AND RESPONSIBILITIES

Both parties agree on the following:

1. To designate contact person(s), i.e., Coordinator, to facilitate the contacts and progress of the Work.

2. Implementing joint projects and sharing experiences:

(i) To jointly prepare project proposals and submit to the relevant National and International funding agencies on mutually agreed subjects on Civil, Computer Science, Computer Applications, Electrical, Electronics & Communication, IT, Mechanical, Metallurgical & Materials to implement the approved projects by using capacities of both parties.

(ii) To exchange faculty members, experts and students for sharing knowledge and experiences for shorter or longer research visits, sharing or creation of educational material & resources and cultural exchanges of students.

3. Collaboration to educate the students and young scientists/faculty members:

The respective faculty members/engineers/scientists of NITJSR and AJU will together formulate the syllabi for academic programmes, new courses, joint research projects and provide training for skill-oriented human resource development of the stakeholder within the areas of cooperation, faculty/research scholar exchange program, joint training programmes/ workshops etc.

National Institute of Technology Jamshedpur (NITJSR)

National Institute of Technology, Jamshedpur was founded as the Regional Institute of Technology in 1960. It was among the first eight Regional Engineering Colleges (RECs) established as part of the Second Five-Year Plan (1956-1961). On 27th December 2002, in the line of all other RECs of India, RIT Jamshedpur (may be read as REC Jamshedpur too) was converted to National Institute of Technology Jamshedpur with the status of a Deemed University as per the decision of Govt. of India. The Institute is fully funded and governed by the Ministry of Education (MoE), Government of India since 1st April, 2003. On 15 August 2007, NIT Jamshedpur was given the status of the Institute of National Importance through an Act of the Parliament known as the NIT Act. The Institute has 11 departments including engineering, science and humanities. The Institute, with 200 faculty, 4000 students, 150 administrative and supporting staff, is a self-contained campus. The institute offers B.Tech, M.Tech, M.Des, MCA, MSc, and Ph.D. in various streams of science and engineering. It offers admission in its undergraduate courses of B.Tech through JEE-Main Entrance Examination, which is the pre-requisite for admission in all NITs.

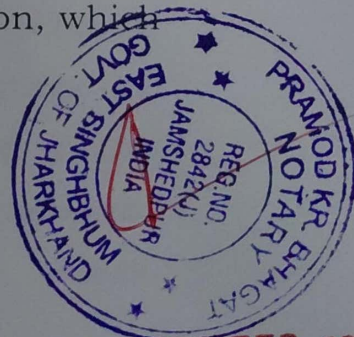
