OBJECTIVE:

The primary objectives of organizing the visit to the National Lok Adalat Programme are as follows:

- 1. To provide practical exposure** to students regarding alternative dispute resolution mechanisms, especially Lok Adalat.
- 2. To enhance understanding of the functioning of Lok Adalats** under the Legal Services Authorities Act, 1987.
- 3. To familiarize students with court procedures** and the role of judges, lawyers, legal services authorities, and conciliators.
- 4. To promote awareness of access to justice** and speedy dispute resolution for economically and socially weaker sections.
- 5. To encourage legal ethics and professional responsibility** among budding legal professionals.
- 6. To supplement classroom learning** through real-time observation of dispute settlement processes.

DETAILS:

The Students of both 1st Year BBA LL.B. and LL.B. of School of Law, **ARKA JAIN University** visited **“National Lok Adalat Programme”** which was held at **Civil Court, Jamshedpur, Sakchi, Jharkhand, on 13th December, 2025** from 10.30 am in the morning. This visit was a part of the University’s experiential learning initiative aimed at bridging the gap between theoretical legal education and practical exposure to the justice delivery system in India.

On that day, when the students started their journey from Arka Jain University to attend the said programme at Civil Court Jamshedpur, then Prof. (Dr.) Praveen Kumar Thakur, respected Dean –in-charge of School of Law and Dr. Archita Dash (Programme Co-ordinator of School of Law) enlightened the students on the significance of the visit of National Lok Adalat to gain the practical exposure to judicial processes and enhances their understanding of legal proceedings.
